FINAL PAYMENT via casino or cashier's check only (***no exceptions***) made payable to **AMBROSIA TOURING COMPANY** (W9 attached) presented to Tour Manager Shannon Puerta prior to performance.

3: DRESSING ROOMS

Purchaser to provide three (3) clean, private dressing rooms for Artists. Rooms should be clean and have electrical outlets, mirrors, **sinks for hand washing (please make sure soap dispensers are working and full), and private restrooms.** Dressing rooms should be comfortable with couches, chairs, **clothing racks with hangers, a portable professional steamer system for wardrobe and at least one full length mirror.** Please have trash cans in all dressing rooms and bathrooms as well as clean fresh towels for 8 people and 8 black hand towels for the stage.

4: SECURITY

Buyer agrees to provide security for artists and their personal property from Load In to Load Out and during any time ARTIST is in a public, non-secured area including restaurants and VIP events. This includes a PURCHASER provided escort through all public pathways including walking to, during and walking back to a secure area after the ARTISTS leave the merchandise table and/or stage after the performance.

5. MERCHANDISE

Purchaser to provide 2-3 8 foot ***black skirted tables***, plus vertical grid panels to hang merchandise. Please also provide one power drop, one 6 socket power strip and three self-hanging LED Clip-On lights to illuminate merchandise tables and panels. Please place all of this in a secure, **WELL LIT** area that is easily visible to the public. **AMBROSIA to receive 100% of merchandise revenue, ARTIST SELLS. 6. GROUND TRANSPORTATION

Arriving by plane – one cargo van for luggage and gear (a total of 22 items) plus one large late model black SUV or one 15 passenger van for 8-9 people (casino shuttle vans are acceptable as long as Ambrosia rides solo). There should be a total of two vehicles.

7. LODGING ACCOMMODATIONS

PURCHASER to provide and pay for lodging on the day of performance and either the day before performance or the day after performance (two nights of lodging). Courtyard by Marriott grade hotel is acceptable. **7 rooms per night are needed.**

Please do not place any band members near the elevators, vending machines, or any area of the hotel that may be extra noisy. Please space band member hotel rooms a few doors away from each other and if possible on separate floors. Please provide each band member a premium experience.

ALL ROOMS MUST BE **NON-SMOKING**. Beds should all be king beds.

-One room for *CHRISTOPHER NORTH* (original member)

-One room for *JOSEPH PUERTA* (original member) and *Shannon Puerta* – **IMPORTANT** –

Shannon must be able to check into this room on her own if Joe is not present

-One room for *BURLEIGH DRUMMOND* (original member) and *Mary Harris* – **IMPORTANT** –

Mary must be able to check into this room on her own if Burleigh is not present

-One room for *BRYAN JACKSON*

-One room for *co lead (TBD)*

-One room for FOH tech (*TBD*)

-One room for Merch Seller *LENFORD HERRON*

8. TICKETS

AMBROSIA requests 18 comp tickets in the second best seating area.

9. MEET AND GREET / VIP'S*

*Ambrosia has the right to refuse VIP and/or merch Meet and Greet (trying to be health conscious)

If there is a M/G, ARTISTS' sincere desire that this Meet and Greet event is fun for everyone. During this time ARTIST'S tour manager Shannon Puerta will most likely be available to help organize this, but in the event she cannot, we ask the following:

- Meet and Greet shall commence 30 minutes prior to performance
- Maximum of 20 people AND a **maximum of 15 minutes**
- There must be a PURCHASER supplied "Event Manager" present at all times. This person shall keep the event orderly at all times causing all participants to form a single file line to greet ARTIST. **NO TOUCHING PLEASE...thank you!**
- ARTIST will not sign any personal items during the Meet and Greet so please make sure your VIP's are aware of this and no personal items are present at the Meet and Greet unless manager approves. Posters for the venue are acceptable and personal items should be kept to one per person.

- It is advised that a professional photographer be on hand to take photos. Taking photos with personal cameras slows down the event and is not recommended.

10. HOSPITALITY, MEALS AND CATERING

- A meal buyout is acceptable. \$100 per day per person for each original member (3) and \$50 for each additional person (6).
- Casino meal vouchers are acceptable and should be accepted as room service payment if room service is available.

***PLEASE MAKE AVAILABLE ALL DAY

- Six (6) Emergen-C packets, fresh coffee with a lot of ½ and 1/2, raw sugar, and Stevia sweetener packets, tea bags of Throat Coat and green tea, VERY hot water via an electric tea pot to be left in Hospitality all day, clean ice, utensils, cups, napkins, sharp knife for slicing and a wine/beer opener.

**Ready for AMBROSIA at band

- Deli tray for 9 people with turkey, roast beef, lettuce and tomato slices
- Mustard/mayonnaise/salt and pepper
- Tuna salad without onions
- Sliced whole wheat bread (½ loaf is fine)
- SLICED cheddar and Swiss cheese
- Fresh fruit
- Vegetable platter w/dip
- 8 oz. pine nut hummus dip
- Sun chips and a sleeve of butter crackers (ritz, town house)
- Tortilla chips with fresh salsa – medium heat
- Chicken noodle soup **IN THE WINTER MONTHS ONLY**
- Single serving drinks including ***CRANBERRY JUICE*** (important), VITAMIN WATER AND LEMONADE
- Sprite and Mt. Dew-6 pack or a liter of each
- One case of ROOM TEMPERATURE water

Dinner – ready at a predetermined time after soundcheck:

- If meal vouchers or meal buyout is not provided, then Purchaser shall provide a catered hot dinner for nine (9) people including green salad, two (2) protein options, vegetables, non-meat carb and dessert. IMPORTANT – TWO OF THE NINE CANNOT EAT ONIONS OR GREEN PEPPERS.

AVAILABLE DURING DINNER AND AFTER SHOW - PLACED IN THE HOSPITALITY AREA:

- 2 quarts of organic whole milk on ice (or one single half gallon)
- One 6 pack of Mike's Hard Lemonade on ice (any flavor) **IN THE SUMMER MONTHS**
- One 6 pack of cold Stella Artois beer
- Two bottles of high quality -cabernet sauvignon wine, red blend – about \$25 per bottle
- After show dessert of one medium bag of Peanut or Almond M&M's and 6 large high quality freshly baked brownies or choc.chip cookies
- 9 To-Go containers with plastic utensils
